Refund Policy: If entries are withdrawn before the closing date, then a refund will be given. After the closing date there will be NO refund. If a competitor does not show, then NO refund will be given.

Riding Times: Riding times will be posted on www.oakhurstfarm.com on Wednesday 10th August, 2016. A status list of entries will also be posted on the Oakhurst website.

Prizes: Ribbons to 5th place. High point or Champion/Reserves, depending on entries. Training through Second Level may have awards for categories depending on number of entries. Third and Fourth level will all be Open category.

High –Point Freestyle Award (Cadora Training Level Freestyle is not eligible for EC Championship or High point awards). A High Point award will be given at the end of the competition.

Ribbons <u>must</u> be picked up the weekend of the show (unless arrangements are made for pickup within one week of the show date.) Ribbons, prizes and awards will not be held.

A limited amount of stabling is available, \$50 per stall, HST included. To reserve a stall please call or email the show secretary. Refreshments will be available on the show grounds.

Directions to Oakhurst: Hwy 7: 10km east of Carleton Place, take Dwyer Hill Road South. 2km turn left on Fernbank Road. 0.5 km to show site at 8249 Fernbank Road. On site stabling and trailer parking is a 8215 Fernbank Road, one lane past farm entrance.

RULES AND CONDITIONS FOR SILVER DRESSAGE COMPETITIONS

- 1. Every class offered herein is covered by the rules and specification of the current rules of EC and will be held and judged in accordance with the EC Rule Book. All competitors are responsible for the knowledge of these rules. The show committee reserves the right to govern all conditions of the show. Questions not covered by these rules shall be decided by the show committee and steward and their decisions will be final. The show committee further reserves the right to cancel or change any class and to limit entries.
- 2. This Oakhurst Farm competition is sanctioned as a Silver competition member of Equine Canada, and is governed in accordance with the EC Rule book. All Canadian entries are required to hold both an EC passport and a valid EC horse license to compete, or if owned by a Temporary Sport License holder, a Temporary Horse Registration form must be purchased at each competition entered. Foreign entries must sign an Affidavit (general rule A602.05) Passports must be handed to the show secretary before horses will be allowed to compete
- 3. Per Article A801, every entry at an EC-sanctioned competition shall constitute an agreement by the person responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition. It is the responsibility of all individuals participating in any capacity in EC-sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules of EC and the additional rules, if any, imposed by the competition. Do not participate in this EC-sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition. (A602.7).
- 4. Equine Canada, the national equestrian federation of Canada, supports adherence to humane treatment of horses in all activities under its jurisdiction.

EC is committed to:

- Upholding the welfare of the horses, regardless of value, as a primary consideration in all activities;
- Requiring that horses be treated with kindness, respect and the compassion that they deserve, and that they never be subjected to mistreatment;
- Ensuring that owners, trainers and exhibitors or their agents use responsible care in the handling, treatment and transportation of their horses as well as horses placed in their care for any purpose;
- Providing for the continuous well-being of horses by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort and safety as a matter of standard operating procedure;
- Continuing to support scientific studies on equine health and welfare;
- Requiring owners, trainers and exhibitors to know and follow their sanctioning organization's rules, and to work within industry regulations in all equestrian competition;
- Reviewing, revising and developing competition rules and regulations that protect the welfare of the horses

The standard by which conduct or treatment will be measured is that which a person informed and experienced in generally accepted equine training and exhibition procedures, would determine to be neither cruel, abusive, nor inhumane. (A602.3(f))

- 5. No HC entries will be allowed.
- 6. No longeing in warm-up area.
- 7. A photocopy of a negative 2016 Coggins Test must be submitted with each entry,
- 8. Competition numbers must be worn and visible at all times in the schooling and exercise areas as well as in the competition ring.
- 9. Any horse entered in any class at a competition may, while on the competition grounds, be selected for equine medication control testing.
- 10. Horses may compete in a maximum of 4 technical tests in one day at 2 consecutive levels, including the corresponding Freestyle Class.

- 11. Competitors must have achieved 55% in one technical test at the appropriate level, either at a previous show or the current show, to be eligible to enter a freestyle class. Under Dressage Rule E10.3.4, please provide 2 functioning copies of your Freestyle music. To qualify for the Silver Championships 2016: a minimum of 55%, 2 scores, 2 shows (1 score from each show).
- 12. Riders and Owners are required to be members of the OEF or other PSO. In addition, a minimum of an EC Silver Competitive License is required for both owners and riders. You may contact the OEF for an application form. All athletes, regardless of age or level of competition, must wear properly fitted and fastened approved protective headgear at all times when mounted at any EC-sanctioned Dressage competition at the event location (E.4.0).
- 13. **Person Responsible** The Person Responsible (PR) for a horse must be an adult who has or shares responsibility for the care, training, custody and performance of the horse, and who has official responsibility for that horse under EC Rules. The PR is liable under penalty provisions of the applicable EC Rules for any rule violations. Every entry form for an EC sanctioned competition must identify the PR and be signed by the PR.

The PR is ultimately responsible for the condition, fitness and management of the horse, and is alone responsible for any act performed by himself/herself, or any other person with authorized access to the horse, in the stables, elsewhere on the grounds, or while the horse is being ridden, driven or exercised.

A: For adult entries into EC sanctioned competitions, the PR shall be either the trainer, the owner of the horse, or the competitor who rides or drives the horse during the EC sanctioned competition.

B: For junior entries into EC sanctioned competitions, the junior competitor cannot be the PR. For junior entries, the PR may be either the trainer, the owners of the horse, or a parent/guardian of the junior competitor.

Registered Participant Any person registered with Equine Canada, including Sport Licence Holders, and paying dues to obtain some benefit from Equine Canada.

The cost of a registered participant/non-competitive licence is \$15. However, please note that all provincial equestrian federation members automatically receive EC registered participant status.

EC Member Under the new EC By-laws, EC Members are defined as persons designated as representatives in one of three categories (Equestrian Sports, Provincial and Territorial Sport Organizations, and National Equine Organizations) who meet the qualifications outlined in the By-laws and have been designated by their peers to have voting privileges in relation to EC governance.

Role of the Person Responsible at EC sanctioned competitions: The Person Responsible (PR) is responsible and accountable under the violation and penalty provisions of EC Rules for the care, training, custody and performance of the horse and must be present at the competition as well as sign and provide a license/member number on the competition entry form.

The PR must sign the competition entry form at EC sanctioned competitions.* The PR must be an EC Sport Licence Holder (which is inclusive of the Registered Participant/non-competitive licence) in good standing and/or a provincial federation member in good standing.

*Please note: in the case of junior entries, a parent/guardian is entitled to sign as PR and must be at minimum, an EC Registered Participant in good standing. In the case of United States Equestrian Federation (USEF) member entries, the PR may be a USEF member in good standing.
